ASX Announcement 19 September 2013

Drilling commences at Nordgruva copper/zinc (Drake / Panoramic JV)

Drake, with its joint venture partner in the Nordgruva project, Panoramic Resources Limited advises that diamond drilling and down hole geophysics at the **Nordgruva Copper Zinc prospect** has begun.

Initially a single diamond drill hole to a depth of approximately 600m will target one of five exceptional targets identified from a detailed airborne electromagnetic (VTEM) survey flown by Drake in 2012. These targets are considered to have a similar geophysical signature to the high grade historic copper mines in the district. See ASX announcement 8 August 2012 for more details.

Nordgruva is part of the Røros mining district in central Norway (See Figure 1) which has a copper/zinc mining history extending back over 300 years from multiple sites.

The planned hole is targeting one of the most extensive modelled plates near Kongens with dimensions in the order of 1500m by 750m. The target is interpreted to be in the stratigraphic position of the main mineralisation in this well-endowed, historical copper mining district. Results are expected in November.




Figure One: Drake has a number of assets prospective for copper, nickel, gold and iron across the Nordic region
